Department: Department of Recreation and Sport Management, University of Taipei (UT)

Department: Sports Centre, University of Malaya (UM)

I. Degree Conferral

Upon successfully completing the Dual Master Degree Program, participating students who meet graduation requirements for this Program will be conferred an accredited degrees from UT, Republic of China (Taiwan) and an accredited degree from UM, Malaysia.

II. Eligibility, Application Procedure, and Selection Process

Applicant's qualifications, application procedure, selection process, and quotas will be resolved through the consultation between both institutions. The detailed clauses will be described in the Addendum to this Agreement.

III. Length of Study and Credit Hours

- a. A period of study at two institutions required to satisfy the requirements for this Program will be resolved through the consultation between the two institutions.
- b. Students who meet bilateral graduation qualifications may receive bilateral degrees. The academic term for the Dual Master Degree Program shall be in accordance with the following regulations:
 1. The academic term for a master's degree shall be no less than two semesters at UT and 12 months at UM.
 2. Students pursuing a master's degree shall study more than 12 months in the two universities.
 3. The credits and course hours of the two universities shall be combined, but the credits shall separately meet at least one-third of the total credits.
 4. Students should work with advisors from two universities to prepare "progress report for each semester" to show the work that students have done at UM. The department-level faculty meeting in UT should review this progress report based on profession and objectivity. If the faculty meeting decides some required capacity does not been proved by this progress report, students need to take some courses in their study period.

IV. Articulated Curriculum and Terms of Degree Conferral

- a. The Addendum to Agreement for Dual Master Degree Programme shall include the following matters:
 1. Qualifications, requirements, and quotas for admission (Qualifications and requirements shall meet the regulations regarding international student enrollment in The University and other related laws and regulations.)
 2. Reviewing or screening methods
 3. Bridging courses offered
 4. Regulations regarding transfer of credits
 5. The duration of study and academic terms in the two universities (shall not violate Article III of

this agreement and the related laws and regulations).

6. Agreement for co-advising of master's thesis.
7. Regulations regarding degree conferral
8. Enrollment, suspension of university, resumption of university, withdrawal and other proceedings.
9. Related stipulations of charges (including related expense of tuitions, class credits expenses, accommodation, etc.)
10. Acquired social welfare, insurance, and scholarship
11. Annulment or modification of the Agreement
12. Other matters

V. Thesis Supervision

- a. The supervision of thesis will be resolved through the consent between faculty members from both universities. The related details are described in the subsequent agreement on Joint Supervision of Master's Thesis.
- b. The Dual Master Degree cooperation requires the signatures of both of the cooperating universities to be implemented.
- c. The "Agreement for Co-Advising of Master's Thesis" shall include the following matters:
 1. Student's name
 2. Co-advisor's name
 3. Way of qualification evaluation
 4. Research topic
 5. Duration of study and academic terms in the two universities
 6. Language used in thesis and abstract writing
 7. Composition of the thesis defense committee and oral defense regulations
 8. Regulations regarding degree conferral
 9. Publication of Papers and Ownership of Intellectual Property.
 10. Annulment or modification of the Agreement

VI. Credit Transfer and Acceptance

- a. Explicitly list the courses run by both institutions as a reference to credit transfer.
- b. The home institution determines whether or not the courses the participants take at the host institution will be granted.
- c. Both institutions need to list the courses as a reference to credit transfer so that participants of this Program can meet graduation requirements.
- d. Program participants are required to take at least 19 credits in UT (Including master's thesis and independent research credits)

VII. Matriculation, Registration for Courses, and Grading

- a. The process of matriculation and registration for courses, and grading shall conform to the academic policies of both institutions.
- b. UT and UM staffs are responsible for advising students in course registration. An official transcript or the progress report from the host institution must be received by the home institution upon successful completion of the semester.

VIII. Tuition and Fees

- a. Participants of this Program are responsible for paying tuition to their home institution. Tuition fees at the host institution are waived. Nonetheless, program participants are required to pay thesis advising fee to their host institution.
- b. At the time the UT participants of this Program study at UM₂, they shall also enroll at UT and pay student insurance and Internet access fees.

c. Dorm fees at the host institution are paid by participants of this Program.

IX. Health and Injury Insurance Policy

Participants of this Program are required to purchase appropriate health and injury insurance.

X. Effectiveness, Modification, and Termination

This Agreement shall take effect on the date of final signature. This Annexure One agreement may be terminated according to the same terms set forth in Memorandum of Agreement for Dual Master Degree Programme between UT and UM. If either institution intends to terminate or to modify this Agreement, a written notice should be given to the other institution six (6) months prior to the desired effective date of termination.

XI. If terms and conditions of this Agreement are not mentioned, the parties to this Annexure One hereby agree to consult under terms of Dual Master Degree Program Agreement between both institutions.
