It can be conducted through interviews, lectures, visits, etc. After the activity, the pilot teacher record form must be filled in and sent to the Teaching Development Center for review.</p> <p>New teachers who accept the guidance can reduce the basic teaching hours by 2 hours per week to apply for the National Science Council, the Ministry of Education or the industry-government-university cooperation program, and must submit the program application certificate before the end of the semester; new teachers For teachers with special expertise, upon approval by the Advisory Committee of the Teaching Development Center, their program application may be replaced by digital teaching materials or specialty training teaching materials.</p>

Business Description	<p>Our school aims to improve the quality of teaching, research, guidance and services of full-time teachers (including professional and technical personnel) and promote the professional growth of teachers. Full-time teachers are evaluated every four years. However, newly hired teachers will only receive school-level evaluation after serving for two years. The evaluation for the first two years will be handled by the department (institute, center, degree program).</p> <p>The evaluation scores are divided into two categories: branch-level and department-level, accounting for 70% and 30% respectively. The full score is calculated as 100 points. If the sum of the two items reaches 70%, it means passing the evaluation.</p> <p>1. School-level scores include three items: teaching, research, tutoring and service. The scores are generated by the evaluation system. Among them, the raw scores for teaching, research, tutoring and service are weighted by the evaluated teachers according to the scoring rules. The total weight of the three items must be 100%.</p> <p>2. Department (institute, center, degree program)-level scores are determined by each department (institute, center, degree program) according to its characteristics and needs, including teacher</p>

	evaluation items, standards, procedures, teacher evaluation points and other related matters.

If the teacher's total average of all valid questionnaire scores in a single semester does not reach 3 points, or the total average of all valid questionnaire scores in two consecutive semesters does not reach 3.5 points, full-time teachers should receive guidance coaching, and It is not allowed to exceed the working hours and take part-time classes outside the school; part-time teachers will no longer be appointed within 2 years from the semester when the results of the teaching opinion survey are announced.
